PERSONAL CONVEYANCE

First off, let's just get this out of the way... Personal conveyance is not allowed to be used to extend your 11-hour drive time, 14 hours on duty, or to advance your load.

Fort Transfer Company is strongly committed to full compliance with the current federal hours of service (HOS) regulations. A major element of individual compliance with the hours-of-service regulations is the use of a Commercial Motor Vehicle for Personal Conveyance, 49 CFR 395.8. Fort Transfer Company authorizes our company drivers, lease drivers and owner operators to use a Commercial Motor Vehicle (CMV) while off-duty for Personal Conveyance per the authorized uses below.

When to Use

Drivers are required to document such use as off duty on their Records of Duty Status, irrespective of the method used to record the driver's Hours of Service (e.g., paper logs, electronic logging devices ELD, etc.). A driver may record time operating a CMV for personal conveyance (i.e., for personal use or reasons) as off-duty only when the driver is relieved from work and all responsibility for performing work by Fort Transfer Company. Personal conveyance does not reduce a driver's or Fort Transfer Company responsibility to operate a CMV safely.

Conveyance to Safe Haven, I

Fort Transfer Company authorizes the use of a CMV while off-duty for personal conveyance: Time spent traveling from a driver's in-route lodging (such as a motel or truck stop) to restaurants and entertainment facilities.

Conveyance to Save Haven, II

Time spent traveling to a nearby, reasonable, safe location to obtain required rest after a loading or unloading delay and no available parking on site. The time spent driving under personal conveyance must not exceed the 11 hours driving and 14 hours on duty' time to allow the driver adequate time to obtain the required rest in accordance with minimum off-duty periods under 49 CFR 395.3(a) (1) before returning to on-duty driving, and the resting location must be the first such location reasonably available. FMCSA recommends that the driver annotate on the HOS if he/she cannot park at the nearest location and must proceed to another location.

Conveyance to Home

Commuting between the driver's terminal and his or her residence, between trailer-drop lots and the driver's residence, and between work sites and his or her residence. In these scenarios, the commuting distance combined with the release from work and start to work times must allow the driver enough time to obtain the required restorative rest as to ensure the drive is not fatigued.

Conveyance While Loaded

Moving a CMV at the request of a Federal, State or local law enforcement official, or a first responder to relocate the CMV during the 10-hour break period. However, the CMV must be moved no farther than the nearest reasonable and safe area to complete the rest period, while on 'off duty' status.

- 3. We are identifying excess cost and right sizing our fleet to adapt to the environment. Through attrition our truck count has naturally decreased to a size that can now handle the current demands of our customers. Each truck should be seeing better utilization with that adjustment.

Through these strategies, we are becoming a better and stronger company. We have learned to "grow from our adversities," which is a good approach to take in life along with being biblical based (Rom 5:3).
